## Seniors of tomorrow – We need your opinion!

Dear fellow citizen,

### **The Parliament of the German Speaking Community of Belgium has drawn you by lot: you can become a member of the Citizens' Assembly!**

Register and meet around 29 other citizens drawn by lot. Together you will have the opportunity to give your opinion to politicians on the subject of "Seniors of tomorrow: How can our politicians ensure that life in old age in East Belgium is attractive and enriching?"

In **around 5 meetings**, you and the other members will gather information, discuss and then formulate recommendations to politicians. You will be paid an expense allowance and travel expenses for attending the meetings.

**Anyone can take part: No special knowledge is required!** You will receive information material and can listen to experts to familiarize yourself with the topic. The idea is that ordinary citizens express their opinions. The discussion is accompanied by a professional facilitator to ensure that everyone has their say.

Some of the participants then present the recommendations drawn up by the citizens' assembly to the politicians. The politicians then explain in a public meeting how they will implement the recommendations. A year later, a check is made to see whether the politicians have kept their promises. **The Citizens' Dialogue can therefore have a direct influence on East Belgian politics!**

If you would like to take part, please complete the attached yellow form and return it to me by post or email by May 15, 2025. We will then draw lots for the final 30 participants from all the confirmations received. If you have any questions or concerns of any kind, please do not hesitate to contact me.

Let our politicians know what you think about the topic of "seniors of tomorrow" and help ensure that life in old age in East Belgium is attractive and enriching.

**Note:**

If you hold a mandate or a function from the following list<sup>1</sup>, you are unfortunately not allowed to participate in the Citizens' assembly:

- a. Member of the Parliament, the House of Representatives, the Senate, the Walloon Parliament and the European Parliament,
- b. Member of the federal Government, a Community or Regional Government,
- c. Governor of a province or Vice-governor of the province Flemish Brabant, deputy Governor of the Region Brussels-Capital, senior official or Provincial Governor designated by the Government of the Region Brussels-Capital.
- d. Member of the Provincial Council or of the Provincial College of the Province of Liège,
- e. District commissioner,
- f. Any office in a public or private institution, which is exercised as representative of the state, a community, a region, a province or a municipality, insofar as this mandate comprises more entitlements than the simple membership in the general assembly or the council of administration,
- g. Mayor, alder(wo)man, president of the Public Centre for Social Welfare (PCSW), member of the municipal council or the PCSW council,
- h. A mandate under the direct oversight of the Parliament or Government, with exception of the members of the staff of the educational sector,
- i. A leading mandate (senior civil servant, director, managing director) in an institution of public interest of the German-speaking Community, as defined in the article 87 of the Decree of 25 May 2009 on the Financial Regulation of the German Speaking Community.
